Governing policy and procedures

These terms and conditions are subject to University policy and the University's *Course Fees and Charges Policy* which is published in the Melbourne Policy Library.

Who these terms and conditions relate to

The terms and conditions apply to domestic students enrolled in a domestic fee-paying place at the University of Melbourne and relate to the calculation and payment of tuition fees for commencing and continuing domestic students in 2015. This includes domestic students enrolled:

- in a domestic fee place in an undergraduate, graduate coursework, or graduate research course (including Masters by Research, Doctoral and PhD candidates); or
- in Community Access Program (CAP) subjects; or
- in an incoming Study Abroad course.

Coverage includes students with Australian citizenship who are studying from overseas in an Australian fee-paying place.

The terms and conditions do not apply to:

- domestic students enrolled in courses offered by MBS Ltd or the School of Melbourne Custom Programs;
- domestic students enrolled in a Commonwealth supported place (CSP);
- domestic students enrolled under the Research Training Scheme (RTS).

Domestic student classification

A domestic student:

- is an Australian citizen or permanent resident; or
- holds a permanent Australian humanitarian visa; or
- is a New Zealand citizen.

If you are not an Australian or New Zealand citizen or an Australian permanent resident and you do not hold a permanent Australian humanitarian visa, you should refer to the enrolment policy and fees procedures for international students. The tuition fee terms and conditions for international students enrolling at the University are outlined under *The University of Melbourne tuition fees 2015. Terms and conditions for international students*.

Why it is important

It is important that you read these *Terms and conditions* and the University of Melbourne's *Course Fees and Charges Policy*, and *Fees and Charges procedures* before completing your administrative enrolment. Once you enrol, you will be bound by the University's fees policy, procedures, terms and conditions, and are agreeing to pay tuition fees for every year in which you are enrolled.

Note that the tuition fees detailed relate to 2015 only and are subject to annual review. Tuition fees do not include costs such as certain other costs that may be required as part of your enrolment. There may be additional costs, fees and charges in some cases.

All tuition and other fees are paid in Australian dollars (\$AUD).

The University of Melbourne tuition fees 2015. Terms and conditions for Australian fee-paying students.

Policy amendments

These terms and conditions take effect for all students from 1 January 2015.

The University reserves the right to amend the *Course Fees and Charges Policy*, *Fees and Charges procedures* and *Terms and Conditions* as required. Any changes will be notified in writing.

The Goods and Services Tax (GST) does not currently apply to tuition fees. Should this change, the University reserves the right to charge GST in addition to the published fee.

Enrolment options for domestic students commencing a course in 2015

Domestic students commencing in 2015 are enrolled in a Commonwealth supported place (CSP), a place funded under the Research Training Scheme (RTS), or in an Australian fee-paying place for graduate courses, Community Access Program (CAP) subjects, or incoming Study Abroad.

Commonwealth supported places (CSPs)

- CSPs are available to eligible undergraduate and some graduate students.
- Students enrolled in a CSP are required to pay any mandatory upfront student contributions to maintain enrolment.
- Domestic students enrolled in a Commonwealth supported place (CSP) should refer to the *Fees and Charges for Commonwealth Supported Places Procedure (MPF1051)* in the Melbourne Policy Library, and the *Subject EFTSL & Census Dates* for details about fees paid including student contributions

RTS places

- RTS places are available to eligible graduate research students.
- RTS enrolments are subsidised by the Australian Government and are exempt from tuition fee payments for the normal duration of their course.
- Domestic students enrolled under the Research Training Scheme (RTS) should refer to the *Fees and Charges for Research Training Scheme Places Procedure (MPF1211)* in the Melbourne Policy Library.

Australian fee-paying places

- Australian fee-paying places are available for:
 - graduate courses:
 - single subject study for some undergraduate and graduate coursework subjects through the Community Access Program (CAP);
 - incoming Study Abroad students.
- There are no Australian fee-paying places available to commencing domestic undergraduate students.
- Students enrolled in an Australian fee-paying place are required to pay tuition fees to maintain enrolment. The tuition fees you pay will depend on the course that you commence, as outlined in these *Terms and conditions* and the University of Melbourne's *Course Fees and Charges Policy*, and *Fees and Charges procedures*.

FEE-HELP

FEE-HELP loans are provided by the Commonwealth Government to eligible Australian fee-paying students to help pay part or all of their tuition fees. For eligibility and requirements check the Study Assist website: studyassist.gov.au

You can apply for FEE-HELP by completing the online Request for FEE-HELP Assistance application as part of your enrolment.

- Submit a 'Request for FEE-HELP Assistance' form. All eligible Australian fee-paying students who wish to request a FEE-HELP loan must make the application prior to the fee due date or the subject census date, whichever is the earliest.
- Students who have submitted a 'Request for FEE-HELP Assistance' form may still make full or partial upfront payments by their subject census dates if they wish.

Tuition fees for Australian fee-paying domestic students commencing a course in 2015

The tuition fees you pay will depend on the course that you commence.

Tuition fees are charged for each year that you are enrolled and you will pay tuition fees according to your specific enrolment in any given semester. You are required to pay your tuition fees to maintain your enrolment.

Tuition fees for Australian fee-paying domestic students continuing a course in 2015

The tuition fees you pay will depend on the course that you are enrolled in, and the year that you commenced in that course.

Tuition fees are charged for each year that you are enrolled and you will pay tuition fees according to your specific enrolment in any given semester. You are required to pay your tuition fees to maintain your enrolment.

What the tuition fees cover

Tuition fees cover the cost of tuition.

Tuition fees do not cover other costs such as:

- Books and equipment, or
- Certain other costs and services, for example, some club memberships, Melbourne University Sport services or Student Union activities. Students may be required to pay additional fees.

Students have access to a range of free support services and facilities including:

- Programs such as Orientation
- Services such as student housing and employment services.

For details about other fees and costs associated with your studies see *Section 1: Governing policy and procedures, terms and conditions and the fees to be paid - Other fees and costs for domestic students commencing or continuing a course in 2015.*

When you pay

Tuition fee payments are made in advance of each study period. For details about payment options, invoices, due dates, and refunds see *Section 3: Payments and refunds - Information relating to the payment of fees in 2015.*

Note that in 2015:

- You have two payment options: standard instalment or dual instalment. Your invoice will be available on line via your student portal as soon as you enrol in your subjects.
- It is your responsibility to pay your fees and complete your enrolment by the published date; otherwise a late fee will be levied.
- If your fees remain unpaid, your enrolment will be cancelled and you will then need to reapply for admission to the course. You will remain liable for any outstanding debt.

Variations in the fees quoted

The tuition fees detailed relate to 2015 only. These fees are subject to annual review and may be adjusted to take into account price and demand factors.

Maximum yearly increases

The University provides a guarantee to domestic students who enrol in an Australian fee-paying place that:

- The tuition fee will not increase by more than 10 per cent per annum for students enrolled in a graduate course and paying a course-based fee.

No guarantee is provided on limits to fee increases for:

- Domestic students enrolled in an Australian fee-paying place in an undergraduate course
- Domestic students enrolled in an Australian fee-paying place in a graduate course and paying a subject-based fee
- Community Access Program subject fees
- Incoming Study Abroad fees.

These fees are subject to annual review and may be adjusted to take into account price and demand factors.

If you commence in Semester 2

If you are commencing your course in Semester 2, 2015, the fees for your first semester of study will be those applying in 2015. For the first semester of 2016, the fees you pay will be those approved for the 2016 academic year.

If you defer your studies

If you have an offer to study at the University in 2015 and you defer your studies until 2016, the fees you pay on commencement will be those approved for the 2016 academic year.

If you transfer to a new course

For undergraduate students transferring to a new undergraduate course:

- The fees you pay will be those set for the subjects into which you enrol at the time of transfer.

For graduate students transferring to a new graduate course:

- The fees you pay will be those set for the new course into which you enrol.

For Study Abroad students transferring to a new Study Abroad course:

- The fees you pay will be those set for the new course into which you enrol.

If your enrolment is terminated

Students whose enrolment is terminated either for poor academic performance, disciplinary grounds or for failure to re-enrol in a timely fashion, if readmitted at any future time, will be required to pay fees according to the fee policy and procedures applicable at the time of readmission, not the policy that applied under their original enrolment. This also applies to students whose enrolment is terminated for unpaid fees or other outstanding debt and who are ineligible for reinstatement.

If you change subjects within your course

Subject fees: undergraduate courses and graduate enrolments with subject-based fees

Changing to subjects in different fee bands or changes to study load will result in a change to your fee liability (refer to *Section 3: Payments and refunds - Variations to fees owing*).

- If the subject you add to your enrolment is charged at a higher rate than the one from which you withdraw, additional tuition fees will be payable.
- If the subject you add to your enrolment is charged at a lower rate than the one from which you withdraw your subsequent semester's tuition fee will be credited or you may apply for a refund (refer to *Section 3: Payments and refunds - Refunds*).
- If you withdraw from a subject you must do so by the census date for that subject or you will be charged for the subject (refer to *Section 3: Payments and refunds - Variations to fees owing*).

Course fees: graduate enrolments with course-based fees

Your course tuition fee will only change if you change your study load (EFTSL).

- If you increase the number of subjects in which you are enrolled, or change to subjects of a higher weighting, your fee liability will increase.
- If you reduce the number of subjects in which you are enrolled or change to subjects of a lower weighting, you may decrease your fee liability and may be eligible for a refund. However, you must have withdrawn from subject(s) by the subject census date or you will be charged for the original study load.

Single subject (CAP) fees

- Your fees will vary depending on your enrolment (assessed or non-assessed mode), the subjects you choose (the area of study and discipline), as well as the study load (or credit point value) of each subject.

Course fees: Study Abroad

- Undergraduate Study Abroad: Your course tuition fee will not change.
- Graduate Study Abroad: Your course tuition fee will not change unless you change to a majority of subjects within the other graduate band, resulting in a change of Study Abroad course.

Other fees and costs for domestic students commencing or continuing a course in 2015

There are other fees and costs associated with your studies that you need to consider.

You are required to pay these fees in order to maintain your enrolment

Student Services and Amenities Fee

The Commonwealth Government has introduced a Student Services and Amenities Fee (SSAF). The SSAF you are required to pay will vary depending on your enrolment. Details about the fee and how it will be charged in 2015 are available at futurestudents.unimelb.edu.au/admissions/fees

Other costs

Course costs

For enrolments with subject-based fees, note that every subject at the University has been assigned to a discipline fee band. The subject fees are set within a fixed number of bands which are based on The Australian Government's discipline classification of the subject. The discipline fee band for each subject is determined by the content of the subject, not the course of which it forms a part, nor the faculty or school which is responsible for teaching it. Different prices are charged for undergraduate subjects, graduate subjects and Community Access Program study.

Section 2: Fees for 2015 and fee calculations

For the tables outlined in section 2 see the accompanying document: *The University of Melbourne tuition fees 2015. Tuition fee tables for Australian fee-paying students*, which forms part of the tuition fee terms and conditions for Australian fee-paying students.

Undergraduate course tuition fees for 2015

This applies to continuing domestic undergraduate students in 2015.

All undergraduate courses have subject-based fees. Domestic students continuing their enrolment in an Australian fee-paying place in an undergraduate course at the University of Melbourne in 2015 will pay tuition fees based on the particular subjects they choose to study. The amount charged is the sum of the fees for all subjects in which you enrol.

The 2015 Australian undergraduate subject fees are shown in table 1 (Tuition fee tables for Australian fee-paying students).

Note that Australian fee-paying places are not available to commencing domestic undergraduate students.

About the undergraduate subject fees

Every undergraduate subject at the University has been assigned to a discipline fee band. The subject fees are set within a fixed number of bands which are based on The Australian Government's discipline classification of the subject. The discipline fee band for each subject is determined by the content of the subject, not the course of which it forms a part, nor the faculty or school which is responsible for teaching it. The fees are based on the cost of teaching the subjects in the discipline fee band and the demand for the discipline in which they fall.

The subject fees in table 1 set out the basis for calculating your tuition fees but do not necessarily represent the fees for a typical undergraduate enrolment. The fees shown in table 1 are for each 100 credit points (1 EFTSL)¹ of study in that discipline fee band. Most undergraduate courses require students to enrol in subjects from more than one discipline fee band for a total study load across all subjects of 100 credit points per year.

Calculating your tuition fees

Each subject that you undertake has an EFTSL, or credit point value, and is assigned to a discipline fee band.

Your fees are calculated based on the EFTSL value of the subjects you take in each semester and the discipline fee band for each subject. The total fees you will pay in any year are the sum of the subject fees for all subjects in which you are enrolled.

The *Handbook* lists all the subjects you can take in your course and their corresponding subject codes: handbook.unimelb.edu.au
The subject EFTSL value can be used to work out the cost of each subject: fee.acs.unimelb.edu.au

Example tuition fee calculation for one subject.

For a subject worth 12.5 credit points (0.125 EFTSL), the fee charged for the subject is 0.125 multiplied by the \$AUD/EFTSL fee for the discipline fee band.

Note that year-long subjects are usually required to have their fees paid in full in Semester 1. If, for example, a year-long subject is worth 37.5 credit points (0.375 EFTSL) then the fee is charged in Semester 1 and is calculated as 0.375 multiplied by the \$AUD/EFTSL fee.

Example tuition fee calculation for one year of study.

Angela is a domestic student who continues her enrolment in a Bachelor of Science in 2015. She enrolls in 8 subjects for a total of 100 credit points (1 EFTSL), or a standard full-time study load for one year of study:

- 2 commerce subjects (12.5 credit points each)
- 2 maths subjects (12.5 credit points each)
- 4 science subjects (12.5 credit points each)

In this example, the subject fees in 2015 are \$29,728/EFTSL for Commerce, \$27,936/EFTSL for Mathematics, \$32,640/EFTSL for Science.

Angela's tuition fees for 2015 are calculated as:

$$\begin{aligned} &(2 \times 0.125 \times \$29,728) + \\ &(2 \times 0.125 \times \$27,936) + \\ &(4 \times 0.125 \times \$32,640) \\ &= \$30,736 \end{aligned}$$

¹ 100 credit points is a standard full-time study load for one year of study.

Graduate course tuition fees for 2015

Graduate enrolments with course-based fees

This applies to:

- All commencing graduate students in 2015*
- All continuing graduate students in 2015 who commenced a graduate course with course-based fees in 2010 or later.

*except graduate students in Office for Environmental Programs courses.

Domestic students enrolling in an Australian fee-paying place at the University of Melbourne as a graduate enrolment with course-based fees in 2015 will pay tuition fees based on their annual course cost and study load. The amount you are charged is the course fee listed per EFTSL enrolled. If you are studying more or less than one EFTSL in 2015, your fee will increase or decrease proportionally.

The 2015 Australian graduate course fees are shown in table 2 (Tuition fee tables for Australian fee-paying students)

About the graduate course fees

A course fee has been set for every graduate course at the University. The fees are determined by the course, not the subjects that comprise the course.

The course fees in table 2 set out the basis for calculating your tuition fees showing the fee for each 100 credit points (1 EFTSL)² of study in that course (2015 Australian course fee).

The table also provides an estimate of the tuition fees for the first year of the course, and an indicative total course fee. These fees are provided as a guide only and are based on a typical study load for students commencing the course in semester one 2015. Please note that unless indicated:

- The estimated fee year 1 assumes a full-time study load, commencing semester one, and is for 2015 only.
- The indicative total course fee assumes a full-time study load over the duration shown, commencing semester one 2015, with indexation of the 2015 Australian course fee at 5 per cent per annum for every additional year of study.
- It is assumed that courses less than one EFTSL duration are completed in less than one year and in 2015.

Calculating your tuition fees

Each subject that you undertake has an EFTSL, or credit point value.

Your fees are calculated based on the EFTSL value of the subjects you take in each semester and the course fee. The total fees you will pay in any year will depend on your total study load for the year (comprising the total EFTSL or credit point value for all subjects in which you are enrolled).

The *Handbook* lists all the subjects you can take in your course and their corresponding subject codes: handbook.unimelb.edu.au
The subject EFTSL value can be used to work out the cost of each subject: fee.acs.unimelb.edu.au

Example tuition fee calculation by subject.

For a subject worth 12.5 credit points (0.125 EFTSL), the fee charged for the subject is 0.125 multiplied by the \$AUD/EFTSL fee for your course.

If you undertake 8 subjects worth 12.5 credit points each (0.125 EFTSL) your total study load for the year is 1 EFTSL (8x0.125). The fees charged for these subjects is 1 multiplied by the \$AUD/EFTSL fee for your course.

Example tuition fee calculation for one year of study.

David is a domestic student who enrolls in a Master of Management in 2015. He enrolls in a total of 100 credit points: 0.5 EFTSL in Semester 1 and 0.5 EFTSL in Semester 2.

In this example, the course fee for the Master of Management is \$29,376/EFTSL.

David's tuition fees for 2015 are calculated as:

$$\begin{aligned} &(0.5 \times \$29,376) + \\ &(0.5 \times \$29,376) \\ &= \$29,376 \end{aligned}$$

² 100 credit points is a standard full-time study load for one year of study.

Graduate enrolments with subject-based fees

This applies to:

- All commencing and continuing graduate students in Office for Environmental Programs courses in 2015.
- All continuing graduate students in 2015 who commenced their graduate course in 2009 or earlier.

Domestic students enrolling in an Australian fee-paying place at the University of Melbourne as a graduate enrolment with subject-based fees in 2015 will pay tuition fees based on the particular subjects they choose to study. The amount charged is the sum of the fees for all subjects in which you enrol.

The 2015 Australian graduate subject fees are shown in table 3 (Tuition fee tables for Australian fee-paying students).

About the graduate subject fees

Every graduate subject at the University has been assigned to a discipline fee band. The subject fees are set within a fixed number of bands which are based on The Australian Government's discipline classification of the subject. The discipline fee band for each subject is determined by the content of the subject, not the course of which it forms a part, nor the faculty or school which is responsible for teaching it. The fees are based on the cost of teaching the subjects in the discipline fee band and the demand for the discipline in which they fall.

The subject fees in table 3 set out the basis for calculating your tuition fees but do not necessarily represent the fees for a typical graduate enrolment. The fees shown in table 3 are for each 100 credit points (1 EFTSL)³ of study in that discipline fee band. Graduate courses may require students to enrol in subjects from more than one discipline fee band for the normal study load per year.

Calculating your tuition fees

Each subject that you undertake has an EFTSL, or credit point value, and is assigned to a discipline fee band.

Your fees are calculated based on the EFTSL value of the subjects you take in each semester and the discipline fee band for each subject. The total fees you will pay in any year are the sum of the subject fees for all subjects in which you are enrolled.

The *Handbook* lists all the subjects you can take in your course and their corresponding subject codes: handbook.unimelb.edu.au
The subject EFTSL value can be used to work out the cost of each subject: fee.acs.unimelb.edu.au

Example tuition fee calculation for one subject.

For a subject worth 12.5 credit points (0.125 EFTSL), the fee charged for the subject is 0.125 multiplied by the \$AUD/EFTSL fee for the discipline fee band.

Note that year-long subjects are usually required to have their fees paid in full in Semester 1. If, for example, a year-long subject is worth 37.5 credit points (0.375 EFTSL) then the fee is charged in Semester 1 and is calculated as 0.375 multiplied by the \$AUD/EFTSL fee.

Example tuition fee calculation for one year of study.

Caitlin is a domestic student who enrolls in a Master of Environment in 2015. She enrolls in 8 subjects for a total of 100 credit points (1 EFTSL), or a standard full-time study load for one year of study:

- 3 Agriculture subjects (12.5 credit points each)
- 3 Built environment subjects (12.5 credit points each)
- 1 Education subject (12.5 credit points)
- 1 Science subject (12.5 credit points).

In this example, the subject fees in 2015 are \$23,264/EFTSL for Agriculture, \$30,688/EFTSL for Built Environment, \$20,672/EFTSL for Education, \$30,176/EFTSL for Science.

Caitlin's tuition fees for 2015 are calculated as:

$$\begin{aligned} &(3 \times 0.125 \times \$23,264)+ \\ &(3 \times 0.125 \times \$30,688)+ \\ &(1 \times 0.125 \times \$20,672)+ \\ &(1 \times 0.125 \times \$30,176) \\ &= \$26,588 \end{aligned}$$

³ 100 credit points is a standard full-time study load for one year of study.

Pro-rata variations for graduate research

Tuition fees are charged based on the study load (EFTSL) you undertake in each semester, with 100 credit points (1 EFTSL) the standard full-time study load for one year of study.

For graduate research (RHD) students, tuition fees are charged on a daily pro-rata basis during the period of your enrolment. You will receive an invoice twice per year for each day you are enrolled in research Semester 1 (1 January-30 June) and research Semester 2 (1 July-31 December).

If you are a commencing research student who enrolls after a research semester commencement date, your first research semester fees will be adjusted to take account of the number of days you will actually be enrolled in that semester. Similarly, once you submit your thesis any refund of fees paid in advance will be calculated on a daily pro-rata basis.

Single subject study (CAP) fees for 2015

Applies to:

- Students enrolled in Community Access Program (CAP) subjects. The fees also apply to international students enrolling in single subject study (CAP).

Students enrolling in Single Subject Study in 2015 will pay a tuition fee for each subject that they enrol in.

Your fees will vary depending on your enrolment (assessed or non-assessed mode), the subjects you choose (the area of study and discipline), as well as the study load (or credit point value) of each subject. The amount charged is the sum of the fees for all subjects in which you enrol.

The 2015 Single subject study (CAP) fees are shown in tables 4 and 5 (Tuition fee tables for Australian fee-paying students).

About the Single subject study (CAP) subject fees

Every undergraduate and graduate subject at the University has been assigned to a discipline fee band. The discipline fee band for each subject is determined by the content of the subject, not the course of which it forms a part, nor the faculty or school which is responsible for teaching it.

The Single subject study (CAP) subject fees in tables 4 and 5 set out the basis for calculating your tuition fees but do not necessarily represent the fees for enrolment in a single subject. The fees shown in tables 4 and 5 are for each 100 credit points (1 EFTSL)⁴ of study in that discipline fee band at undergraduate level (table 4) or graduate level (table 5), according to the mode of study selected.

Calculating your tuition fees

Each subject that you undertake has an EFTSL, or credit point value, and is assigned to a discipline fee band.

Your fees are calculated based on the EFTSL value of the subjects you take in each semester, the discipline fee band and level of study for each subject (undergraduate or graduate), and the mode of single subject study selected (assessed or non-assessed mode). The total fees you will pay in any year are the sum of the single study subject fees for all subjects in which you are enrolled.

For details of the subject EFTSL value for each subject see: fee.acs.unimelb.edu.au

Example tuition fee calculation for one subject.

For a subject worth 12.5 credit points (0.125 EFTSL), the fee charged for the subject is 0.125 multiplied by the \$AUD/EFTSL fee for the discipline fee band for the mode of single subject study selected.

Note that year-long subjects are required to have their fees paid in full in Semester 1. If, for example, a year-long subject is worth 37.5 credit points (0.375 EFTSL) then the fee is charged in Semester 1 and is calculated as 0.375 multiplied by the \$AUD/EFTSL fee for the mode of single subject study selected.

Example tuition fee calculation for more than one subject.

Marian is a CAP student who enrolls in two undergraduate subjects (assessed mode) in 2015. She enrolls in a total of 25 credit points (0.25 EFTSL):

2 arts subjects (12.5 credit points each)

In this example, the CAP undergraduate subject fee (assessed mode) for the arts subjects in 2015 is \$16,800/EFTSL. Marian's tuition fees for 2015 are calculated as:

$$(2 \times 0.125 \times \$16,800) = \$4,200$$

Study Abroad course fees for 2015

Domestic students enrolling at the University of Melbourne in a Study Abroad course in 2015 for credit to an overseas institution will pay a tuition fee to the University of Melbourne. This is a set tuition fee per semester enrolled, irrespective of the number of subjects in which you are enrolled. You will pay a fee for every semester enrolled.

The 2015 Study Abroad fees are shown in table 5, *The University of Melbourne tuition fees 2015. Tuition fee tables for international students*.

About the Study Abroad fees

A fee has been set for each Study Abroad course offered by the University. As indicated, the fee is the cost per semester enrolled. Semester 1, 2015 covers the period January to June 2015; Semester 2, 2015: July to December 2015.

Calculating your tuition fees

Example tuition fee calculation for one semester of study.

Marija is a domestic student who enrolls in the undergraduate Study Abroad program. She enrolls for one semester in 2015.

Marija's tuition fees for 2015 are calculated as:

$$\begin{aligned} &(1 \times \$12,580) \\ &= \$12,580 \end{aligned}$$

Section 3: Payments and refunds

Information relating to the payment of fees in 2015

Payment options in 2015

When you enrol, you will be asked to select one of two instalment options for payment of your tuition fees:

- Standard instalment: one payment for the semester or study period cost (this is the default option).
- Dual instalment: the semester or study period cost is halved and payable in two equal instalments. The dual instalment option is not available for Study Abroad enrolments or Community Access Program enrolments.

Payment of instalments is required by the due date listed on your invoice (or if you enrol after the due date, within seven days of enrolment). Invoices are issued electronically only via the student portal.

You normally use the same instalment option throughout a calendar year and may change your instalment option at the commencement of each new year.

All instalment options require at least one payment in advance of the commencement of classes. If your circumstances change significantly in a given year, you may contact Student Administration to discuss payment options.

Year-long subjects

The full subject cost is usually incurred and payable in semester one. If you only enrol in year-long subjects you may wish to consider a dual instalment (two payments made in semester one).

FEE-HELP payment options for fee-paying students

Eligible Australian fee-paying students can either:

- Pay some or all of their tuition fees up front; and/or
- Submit a 'Request for FEE-HELP Assistance' form. All eligible Australian fee-paying students who wish to request a FEE-HELP loan must make the application prior to the fee due date or the subject census date, whichever is the earliest. Students who have submitted a 'Request for FEE-HELP Assistance' form may still make full or partial upfront payments by their subject census dates if they wish.

Due dates for payment

The due date for payment of your tuition fee instalments will be displayed on your invoice available via the Student Portal: my.unimelb.edu.au

It is your responsibility to ensure payments are made by the date specified on your invoice.

- If you anticipate a problem in meeting a fee payment deadline, please contact Student Administration well before the deadline to discuss possible alternative arrangements.
- If your fees remain unpaid, you will incur a late payment fee of \$100. Sanctions will also apply which will restrict your access to results and future enrolments.. Your enrolment in your course will ultimately be cancelled if payment remains outstanding.
- If your enrolment has been cancelled for non-payment of fees and you wish to be reinstated to your course, you are required to apply for reinstatement to Student Administration. A reinstatement fee of \$250 will apply, and payment of all outstanding fees will be required before reinstatement. Applications for reinstatement must be made in the same semester in which your enrolment was cancelled, otherwise the standard course application process applies.
- Your enrolment may also be cancelled if you have other outstanding debts such as library fines or student loans. Cancellation means that your enrolment will lapse and you will not be able to use any facilities at the University. You will remain liable for any outstanding debt.
-

Invoices

When you enrol online, you are required to access your statement of liability on line via the student portal, and arrange to pay any fees owing by the due date listed.

Your tuition fees will be charged based upon the fee policy in place in the year you commenced your course. The amount you will have to pay will be based upon the course and study load, or subjects you have re-enrolled in, your chosen payment option and any monies credited towards your account. Your invoice will be issued electronically only and will be available online, via the Student Portal, prior to each due date.

For students paying by instalments, the due dates for instalments will be available via the Student Portal and advised on the online invoice.

Variations to fees owing

If you change subjects or study load after paying the first instalment for a semester, there may be a variation in your tuition fees owing for that semester or study period.

- Any additional fees must be paid by the due date indicated on your online invoice.
- Any amount owing to you will be credited towards your next fee instalment or can be refunded on lodgement of a refund request.

You should check your Statement of Liability via the Student Portal after changing subjects to verify if any additional tuition fees are due or have been credited.

Special provisions for graduate completions

Adjustments after the submission of a thesis by graduate research students

Tuition fees will always be charged in advance for the full semester cost. If you intend to submit a thesis before the end of a semester, you may be entitled to a refund depending on the date of submission. Once you submit your thesis any refund of fees will be calculated on a daily pro-rata basis.

Example

Robert is an Australian student enrolled in a Master of Commerce (Research) in 2015. He is enrolled for Semester 2 from 1 July 2015 and is undertaking a normal study load of 0.5 EFTSL. In this example, the course fee for the Master of Commerce (Research) is \$29,376/EFTSL.

Robert's tuition fees for Semester 2, 2015 are calculated as:

$$0.5 \times \$29,376 = \$14,688$$

If Robert submits his thesis on 13 September 2015 (before the end of semester), he would only be charged from 1 July to 12 September 2015. His tuition fees would be adjusted to take account of the fact that his second semester will be only 74 days, not 184 days, in duration. His actual tuition fees for Semester 2 are calculated as:

$$0.5 \times 74/184 \times \$29,376 = \$5,907$$

He is entitled to a refund of \$8,781 (\$14,688 - \$5,907)

Late submissions of a minor thesis by graduate coursework students

If a minor thesis is part of your work requirement for a given semester, you should submit this before the start of the next semester. If you are not able to do this then you must re-enrol in the same subject for the next semester and pay the tuition fees for this subject again. If you have completed the thesis and submitted it prior to the subject census date you can apply for a refund. If you do not complete and submit the thesis prior to the census date you are not eligible for a refund of fees.

Extension of research candidature

If you are a graduate research student who has been granted an extension of your candidature, you will continue to be charged fees for the next full payment period.

Refunds

If you withdraw from one or more subjects (including course discontinuation or leave of absence) the University will refund some or all of the tuition fees you have paid in advance if you give timely, formal notice.

Notice given of subject withdrawal	Refund
1. By close of business on the census date ² for the subject	A full refund of all the fees you have paid in advance for that subject.
2. After the census date ² for the subject	No refund will be given for subjects with census dates that have passed. You may apply for a refund in special circumstances only ³

¹If you are deferring, any fees paid in advance can be credited towards your next fee instalment or refunded on lodgement of a refund request in accordance with this Refund

²The census dates for standard Semester 1 and Semester 2 subjects are 31 March and 31 August respectively. Census dates for other teaching periods may vary. ³In some special circumstances, the University, at its discretion, may refund the tuition fees for individual units of study (eg. particular subjects). How to apply for a refund

- To be eligible for a refund you must make any changes prior to the subject census date¹ as above. You can do this by notifying the relevant area.
- If you change your enrolment prior to the subject census date¹ any monies owed to you will automatically be credited to your account and will be applied towards any future fees.
- If you prefer a refund you need to:
 - Complete the application form available from your Student Centre or online at: ask.unimelb.edu.au
 - Apply for the refund within 12 months of withdrawal from the subject or course.

Payment of refunds

1. If you fail to do so, the University reserves the right to deduct outstanding debts or fines owing from the refund amount.
2. Who can the University pay the refund to?	<ul style="list-style-type: none"> You, or the person you nominate; or The sponsoring agency that paid the fees on your behalf.
3. How will it be paid?	<ul style="list-style-type: none"> By cheque or Electronic Funds Transfer.
4. When will it be paid?	<ul style="list-style-type: none"> Within 15 working days of receipt of your application.

Tuition fee discount for University of Melbourne staff and their families

The University of Melbourne offers staff and their immediate families a discount of up to 25% on the tuition fees for some graduate courses and Community Access Program (CAP) subjects.

Discount on Single subject study (CAP) fees for alumni

Research Training Scheme (RTS) place	The Australian government funds higher education institutions to support research training for eligible domestic students undertaking research higher degrees. Single subject study (CAP) fee	A tuition fee for international and Australian fee-paying students enrolled in the Community Access Program that is calculated by subject enrolled, with each subject allocated to a discipline fee band depending on its area of study, and the mode of study (assessed or non-assessed).
Study Abroad fee	A tuition fee for international and Australian fee-paying students enrolled in an incoming Study Abroad course at the University of Melbourne, with fees calculated by semester.
Subject-based fee	A tuition fee for international and Australian fee-paying students calculated by subject enrolled, with each subject allocated to a discipline fee band depending on its area of study. Subject-based fees are relevant to undergraduate courses, graduate courses offered by the Office for Environmental Programs (OEP), and graduate students who commenced in 2009 or earlier.
Study load	<p>Every subject you do is weighted in terms of the proportion that the subject represents in a standard year of full-time study in a given course.</p> <p>A standard annual full-time load of study is equivalent to 100 credit points of study which is also equivalent to 1EFTSL.</p> <p>See <i>EFTSL</i></p>
Why are OEP programs different?	The Office for Environmental programs offers a multi-disciplinary program from 200 subjects across ten faculties in the University. Because the subjects are taught by different areas, they naturally have different costs associated with their teaching. The calculation of tuition fees for international and Australian fee-paying students is dependent on the subjects studied and you are enrolled as a subject-based enrolment.
